

PREVIOUS WORKS OF THE WG

2001: Parties agreed to develop guidelines and criteria for the evaluation of PA to be listed under the SPAW Protocol

2004 listing of PA under the SPAW Protocol, as identified under Article 7 of the Protocol, has been made a priority since 2004 by successive COPs

2008: Guidelines and Criteria for the Evaluation of PA to be Listed under the SPAW Protocol

2010: Annotated format for presentation reports/guidelines and criteria for evaluation of PA to be listed under the SPAW Protocol

2012-2018: 35 PA listed in 9 countries

(Last listed PA: KAW and Roura Natural Reserves in French Guiana and Mt Scenery NP in Saba)

2020: Terms of reference

NOWADAYS

- 3- The development of a co-operation programme in support of listed PA and in keeping with the comments provided by the STAC, with particular attention to the review of gaps and needs, in order to analyse ecological connectivity among sites, and strengthen networking and capacities

THE COTUBANAMA NATIONAL PARK: LISTING PROPOSAL

UNEP(DEPI)/CAR WG.42/INF.22 Add.1









Main feedbacks

Cotubanama National Park fulfils the general PA criteria of both Article 4 of the SPAW Protocol and the UNEP-CEP General Guidelines for SPAW-listed sites.

A couple of transversal areas could benefit from additional informations to substantiate Dominican Republic's application on topics such as adaptations measures to climate change, communication strategy, relationship with monitoring institutions, or further development of small scale fisheries.

There is missing information that, if completed, could contribute to reinforcing Dominican Republic's argumentation. e.g. The park could demonstrate several key management efforts to make sure it meets the general SPAW listed sites criteria.

EXPERTS' DECISION

Experts recommend giving full support to the proposal from the Dominican Republic to include the Cotubanama National Park into the SPAW listing sites.









Further considerations

Experts support that effective management criteria, including (self-) evaluation of the management action, should be stressed on as they are key aspects of the PAs.

Experts suggest to have further discussions on revising the PA listing process to have a stronger emphasis on **management effectiveness**, and less of an "inventory" approach describing the resources. Opportunities to **streamline the process** must be considered.

Experts support a strong focus on capacity development for SPAW sites to help address management effectiveness needs.

They also recommended that all new applications must include a **current management plan** and **performance evaluation** report in order to be considered for listing.

TASK 3 Cooperation programme



1st draft

- The adoption of a bottom-up approach based on the needs of site level managers.
- Activities should be facilitated as much as possible by a coordinating body.
- This document directly corresponded to the task discussed by STAC 8 and included in the Terms of Reference.
- The major elements one would expect to see (purpose, scope, contents/strategy) were there.

2nd draft

- Aims to identify the need for a cooperation framework, and suggests the scope of such a framework.
- Concerns of a scope going beyond STAC discussions.
- Need to reframe the scope of the cooperation framework.
- Need to address Protected Areas most pressing needs.







Recommendations for the STAC



The STAC may wish to recommend to:

- give full support to the proposal from the Government of Dominican Republican and recommand the COP 11 to approve to include the Cotubanama National Park into the SPAW listing sites.
- request Countries to include a current management plan and performance evaluation report in their upcoming applications and to have further discussions about effective management criteria.
- request its Working Group to develop those criteria and revise the protected area listing process in the frame of task 2.
- request its Working Group to go on with its task 4, finish a reporting format on the status of the listed sites to Contracting Parties.
- encourage its Working Group to continue the development of a cooperation program in support of listing protected areas and listed protected areas, outlining options in support of listing protected areas and listed protected areas as outlines above.







Recommendations for the STAC



The STAC may wish to recommend to:

- request the Secretariat and SPAW-RAC to consider opportunities for increased collaboration with existing MPA networks and capacity building initiatives in the region.
- SPAW-RAC recommend the STAC to convince Parties and in particular Signatory Parties to the SPAW protocol to nominate experts in order to diversify skills and expertise, and ensure the most exhaustive geographical and political representation but also as an efficient way to be involved in the SPAW implementation and better voice their needs and wishes in the SPAW protocol.
- improve the RAC and the Working Group involvement in the ACP MEAs project and other (M)PA activities (CamPAM?), for a better integration coordination of the (M)PA actions, possibly support of a small part of the RAC activity, and link with the other sub-programs.
- if deemed necessary, revise the ToR and it in particular the Annex (update the current tasks of the working group).
